## **Helpful Information**

When entering the hospital: notify the church office the date and hospital you will be entering, or after being admitted, so the pastors may serve you while hospitalized. Due to privacy laws, we are not always aware of member hospitalization.

**To request a prayer in church:** call the church office with the specific request by Friday. For last minute, before-the-service requests, write the name of the person for whom the prayer is requested and the specific reason and give it to the officiating Pastor or elder.

**To request a prayer from the prayer chain:** contact Mrs. Lela Higgins at 871-3662.

**To place flowers on the altar for church services**: 1) reserve date by signing the Flower Chart between the church mailboxes; 2) call church office before noon on Wednesday for notice in the bulletin; and 3) order flowers from the florist of your choice, asking them to be delivered to the church by Saturday before 6:30PM. Flowers may be purchased for the altar (one bouquet), the side vases (two bouquets), the pulpit vase, or the lecturn vase. Only natural flowers and/or plants may be used in the chancel.

At the time of a death: contact the pastor immediately and he will help you make all arrangements. The church makes every effort to accommodate the needs of the family in planning funeral services. Arrangements for organ and vocal music are made through the pastor and Director of Music. If a luncheon is desired, the family should contact the church office or pastor with the anticipated number of family members and friends attending.

**Baptisms:** To schedule a Baptism, call the church office. Baptisms are normally scheduled in any worship service where Holy Communion is not scheduled. Private baptisms may be scheduled any time in the Memorial Chapel.

When unable to commune at church: call one of our pastors to request a private communion in your home. These are made on a monthly basis for as long as necessary.

**Memorial Cards:** Within the Lutheran Church it has been a custom for many years to honor departed family and friends with a memorial card, which involves a small donation to a favorite charity or fund of the congregation. Memorial cards are available in the church office.

**To join St. Paul Lutheran Church:** A person may join our parish by being baptized and through the Rite of Confirmation. Adult Instruction Classes are offered once or twice a year. Call the church office for exact starting dates and further information. LCMS members from another church may also transfer their membership into St. Paul.

When moving: inform the church office you are leaving and request a transfer of membership or release. Before requesting a transfer, be sure to contact the pastor of your new church and advise him of your intentions. Request a "transfer" to another Missouri Synod Lutheran Church. Request a "release" to any other church body. When resigning membership, inform the church office of your resignation in writing.

**Address or Phone Number Changes:** Please inform the church office of any changes.

**Cradle Roll:** Children baptized at St. Paul are automatically enrolled in our Cradle Roll. The child being baptized is given a Children's Picture Bible and the family has their picture posted on the board in the church hallway and has members pray for them. If questions, call Sherry Sebert 871-3084.

**Books & CD Library:** provides Christian books, videos and CD's for our members to use. It is located in the corridor leading to the narthex and church. The weekly church services are recorded on CD's for those unable to attend services. Contact the church office if interested in obtaining a CD.

**Parish Hall, Projects Room or Pavilion Rental:** call the church office. There will be a fee charged, depending on the use. The Projects Room is not available during the school year.

**Off to college? Military Service?** The congregation seeks to keep in touch with young people away at college or in the military service. Please notify the church office of the address away from home and help us to keep it current.

**St. Paul Trust Investment Fund:** is an opportunity to build the principal in an account and to enable the interest to fund church related projects. Investments are received anytime. Applications for funding are in the church office.

Thankfully, we continue to have a strong music ministry, compassionate care provided to many (through the Christian Care Committee, Stephen Ministers, Dorcas Lutheran Women in Mission, as well as the Giving Tree), and many other familiar projects. We continue to rely upon God's Word and the Sacraments to deliver to us His promises and good news.

There are other areas that have changed, because we wanted to do better in our service to God and those to whom He wanted us to bless. This report will also present some new ways of sharing the Word of Christ to all. It will show the changes for the good and some not so good. Whatever the change, we can have peace in knowing that Jesus will not change His promise to be with us always and to continue to send the Holy Spirit to help us (Matthew 28:20b, John 16:7). Our Savior is consistent and faithful. For this we are grateful.

## **Board of Education**

Our school continues to be blessed with a dedicated staff. Carol Weber and Paul Schoenknecht were both recognized for their years of service to Lutheran Education. A call was extended to Paul Schoenknecht for principal and Christy Ostrander for teacher and St. Paul has been blessed to have both accept their call. Paul Mueller (8th grade teacher) left in June. Christina Rosencrats was hired to be the director of daycare and preschool teacher. Brenda Hoskey joined us at 5th grade teacher in August, 2017.

Significant efforts have been made to continue to improve the educational experience and share the love of Jesus Christ to all people. The student handbook was updated and approved. Brochures and yard signs were designed and printed in order to market the Lutheran education provided at St. Paul. In order to connect with families, the faculty set a goal to visit all school families prior to the school year. Sixth and seventh grade classrooms were merged for the 2017-2018 academic year. The staff has been preparing for accreditation with an anticipated visit in May 2018.

For a variety of reasons, the hot lunch program continues to serve fewer meals, requiring external support from donors in order to financially balance the program. Further discussion regarding the hot lunch program resulted in a survey for the parents and children of St. Paul. The BOE continued to work with the kitchen staff to ensure a healthy and viable hot lunch program.

Due to several challenges, the BOE decided to eliminate requirements of engagement in the Members Engaged in Mission program instituted in 2015. Recognizing the increasing cost of tuition, Grantparent funding was given to school families who applied in order to assist families in covering the costs of tuition. A small committee of church members worked prayerfully to be good stewards of the funds.

Enrollment for the 2017-2018 academic year was 140 Kndergarten-8th grade and 37 children in preschool.

## **Board of Evangelism**

The board had the Water for the Weary Booth during the Millington Old Fashioned Days Festival. This is an opportunity for the community to see what St. Paul has to offer.

## **Board of Elders**

The Board of Elders first would like to thank Phil Gordon for his years of faithful service to the congregation of St. Paul and our Lord God as he departs from the Elders board. We also welcome Armond Carmona who has filled his seat. We also thank Tim Sergent for serving as the chairman and look forward to serving with Glenn Brown as chairman moving forward.

2017 has been a busy year for the board. St. Paul Lutheran is presently serving or attempting to serve a baptized membership of approximately 2068, with a communicant membership of 1611. Even though our membership has grown over the past 10 years the worship attendance has declined by about 36%, to an average worship attendance of 306. This means only 15% of our baptized members attend worship on any given weekend. This is a troubling trend for the board and we are continually seeking solutions to this difficult struggle.

The departure of Pastor Abatelli has also presented some additional challenges concerning the workload of Pastor Bruner. Certain elders have been taking on more responsibility in the area of visitation and larger roles in the church services such as Bible readings. We have been assisting the guest preachers and helping with Bible studies. In order to properly fill the vacancy, we decided to implement a self study in which many lay members were involved through surveys and collection of historical and present data for use in the study. The study has revealed some new and interesting results, along with some things we have known for a while. Based on this, the elders have convened a call committee with the intent on calling a pastor, preferably with family life background and training. We feel such a person would fit well with our intentional focus on family life to hopefully drive a more active membership which would allow us to better fulfill our mission statement.

On a bright note, our core membership have been very good stewards of the blessings God has poured out on us. Our annual budget is looking very good and the building projects are being paid in a timely fashion. It has been also reported that we have had over 1200 visits by non members in worship this year. Many, of course, visiting more than once.

The elders have also changed our policy regarding funerals. We now have provisions for anyone in our community wishing for a Christian funeral for themselves or family members who profess Christ as their Savior, to be able to hold the funerals at St. Paul and or be served by our pastor. We feel that this is an important mission which we want to pursue.

The elders have reviewed and amended the job descriptions for all of the staff which our board is responsible for. Thanks to a lot of work by Jeremy Petzold.

The Elders decided to offer a part time position to the area retired pastors to see if we can get some help for Pastor Bruner until a called pastor can be installed. This will be a contract for 6 months for 20-25 hours per week. Hopefully this will be accomplished January of 2018.

It has been decided to keep the schedule of Advent and Lent services to be held at 4:00 pm with no service at 7:00 pm as in the past. This was due largely to the 7pm service only being attended by persons working to provide the service. We will continually review this policy in the years to come in case something should change to prompt holding the later service.

Finally the Board of Elders would like to thank all of the people who help to make this mission of God possible in Millington, Michigan. Thank you, Pastor Bruner and Karen, for all you do above and beyond what is required. Thank you, Stacey Force and Diane Mills for your tireless work in the church office. Thank you to all of the sextons, ushers, altar guild, greeters, acolytes, musicians, trustees, janitors, and anyone else I have forgotten who help make our worship and mission possible.

This is the day that the Lord has made. Let us rejoice and be glad in it.

## **Board of Social Concerns**

In January 2017 Pam III resigned. We still have 6 members: Jan McKee, Sue Eilers, Lisa Mohr, Shelli Lugg, Luanne Jarzel, Barbara Bassett.

At the January Council meeting it was suggested to ask the Congregation for donations to help with the lunches we are packing for the Saginaw Rescue Mission. A congregation member requested money for fuel oil this month.

The Giving Tree project helped 16 families, 43 different children. We planned a Craft Fun Day/ Crop for February 18, 2017.

In February, our Craft/Crop day went well. We set a day for another Craft/Crop on October 28th. The Crop/Craft money raised was donated to MMA.

We pack lunches every month the Friday after the first Saturday at 1:30 in Kitchen. Added new account for Mission lunches so anything donated will go straight into this account.

Social Concerns signed up and hosted one of the Lenten Soup Suppers. We had a Taco Bar. Everyone pitched to help.

We again this year hosted the Baby Bottle Boomerang which starts on Mother's Day and bottles are returned by Father's Day. We raised \$825.71 for Positive Alternatives in Caro. Thank you so much, St. Paul, Millington!

We were given the approval to fix up the Multi-Purpose room in May. The floors will be redone and then we can paint. This was on hold because in October Board of Trustee's wanted to switch Nursery and Multi-Purpose room.

As of September, Shelli Lugg will oversee the packing of lunches for Rescue Mission.

In the Fall we held a drive to help the Community Center in Millington. We collected a car load of diapers, vegetables, hair care and body care products, paper towels and more. Generous giving by our congregations!

We had the Fall Craft/Crop Workshop on October 28th. The whole committee pitched in and helped. We were not able to get a Thrivent card, so we contacted local vendors and pitched in. We were able to raise 1,146.10 at the crop which allowed us to give \$1,000 to the General Fund.

This December, we enjoyed helping Wellspring services and our local community with the Giving Tree. We donated a van load of items to Wellspring Lutheran Services. Willard and Carolyn Petzold delivered them again this year. We had helping wrap Giving Tree gifts by the youth group.

## **Memorials and Gifts**

The Memorials Committee made some much needed updates in 2017. You may notice changes in our financial reports from the 2016 Annual Report compared to the 2017 Annual Report.

We have streamlined the Memorials to better steward funds to meet the needs of both the church and school. There are now four types of Memorials people may designate funds to: Church General Fund, School General Fund, Building Fund, and Undesignated. By restricting donations to one of these four groups, we are able to meet more needs throughout the church. Any board or church member can request funds from the Memorial Undesignated account and the committee will evaluate the need, then process the necessary paperwork. As an example: we recently found an altar chalice with a crack. Altar vessels are not a budget item, so the General Fund was not an avenue that could be tapped for the money. The Board of Elders submitted a request to Memorials to purchase a new chalice and matching ciborium for around \$1,300. We had the funds and we now have a new set of vessels.

Specific needs of the church can be met through Memorials by placing the funds in the Undesignated and then placing a request from Memorials to have that need fulfilled. -Jake Petzold made a presentation to Voters' to amend the Constitution of St. Paul that "no future building project may be undertaken while a current building debt exists, unless that project can be funded in its entirety before work begins. If no current building debt exists, the congregation must first raise, at least, 20% of the total estimated project cost.

-The Michigan District is raising funds in conjunction with the 500th Anniversary of The Reformation "Here WE Stand" Campaign to be held in the Breslin Center at Michigan State University in October.

## **Stephen Ministry**

Stephen Ministry is a system through which members of St. Paul are trained and organized to help provide Christian caregiving to members of our congregation and community. This will multiply the amount of caring ministry St. Paul can provide by giving us a whole team of skilled caregivers who are equipped to bring Christ's healing love to people who are grieving, in crisis or experiencing other stresses in life. Stephen Ministry is based on the idea that all Christians are ministers. The responsibility for passing on God's love is for all Christians, not just for a chosen few. God has given us all gifts for ministry and called us to put those gifts to use. Stephen Ministry is a place where people with special gifts for caring ministry can use those gifts to bring Christ's love to people in need. We have many needs for care in our congregation and community: people experiencing divorce, grief, a terminal illness, loss of a job, relocation, an empty nest, retirement, hospitalization, loneliness, and many other stresses or challenges. Often people with needs suffer silently or do not request or receive the level of care they really need. With only one pastor for a congregation our size, you can quickly see why it would be impossible for our pastor to meet every single need of every single person.

Stephen Ministry expands the care St. Paul can offer by equipping and organizing members to provide Christian care. This gives us a larger pool of people with the gifts, skills and calling to bring Christ's love and care to those who most need it. We currently have 13 active Stephen Ministers, as well as 4 Stephen Ministry Leaders who have received additional training through the Stephen Ministry headquarters in St. Louis, MO. In October of 2017, we started a new Training Class with 5 members. After 50 hours of training, these 5 members will be commissioned as Stephen Ministers on Sunday, March 11, 2018. We ask that you fervently pray for all of our Stephen Ministers and their care-receivers.
