Helpful Information

When entering the hospital: In an effort to better serve your spiritual needs, if you are entering the hospital and want a visit from the pastor or a prayer in church, please call the church office with your information. When returning home, please call and update us also. Due to privacy laws, we are not always aware of member hospitalization. Please don't assume the pastors will know. We don't always get a phone call from the hospital, and we do not use media postings for our information.

To request a prayer in church: call the church office with the specific request by Friday. For last minute, before-the-service requests, write the name of the person for whom the prayer is requested and the specific reason and give it to the officiating Pastor or elder.

To request a prayer from the prayer chain: contact the Church Office or Marilyn Daenzer 871-2879.

To place flowers on the altar for church services: 1) reserve date by signing the Flower Chart between the church mailboxes; 2) call church office before noon on Wednesday for notice in the bulletin; and 3) order flowers from the florist of your choice, asking them to be delivered to the church by Saturday before 6PM. Flowers may be purchased for the altar (one bouquet), the side vases (two bouquets), the pulpit vase, or the lecturn vase. Only natural flowers and/or plants may be used in the chancel.

At the time of a death: contact the pastor immediately and he will help you make all arrangements. The church makes every effort to accommodate the needs of the family in planning funeral services. Arrangements for organ and vocal music are made through the pastor and Director of Music. If a luncheon is desired, the family should contact the church office or pastor with the anticipated number of family members and friends attending.

Baptisms: To schedule a Baptism, call the church office. Baptisms are normally scheduled in any worship service where Holy Communion is not scheduled. Private baptisms may be scheduled any time in the Memorial Chapel when the pastor is available.

When unable to commune at church: call one of our pastors to request a private communion in your home. Additional visits can be continued for as long as necessary.

Memorial Cards: Within the Lutheran Church it has been a custom for many years to honor departed family and friends with a memorial card, which involves a small donation to a favorite charity or fund of the congregation. Memorial cards are available in the church office.

To join St. Paul Lutheran Church: A person may join our parish by being baptized and through the Rite of Confirmation. Adult Instruction Classes are offered once or twice a year. Call the church office for exact starting dates and further information. LCMS members from another church may also transfer their membership into St. Paul.

When moving: inform the church office you are leaving and request a transfer of membership or release. Before requesting a transfer, be sure to contact the pastor of your new church and advise him of your intentions. Request a "transfer" to another Missouri Synod Lutheran Church. Request a "release" to any other church body. When resigning membership, inform the church office of your resignation in writing.

Address / Phone Number / Household Changes: Please inform the church office of any changes.

Cradle Roll: Children baptized at St. Paul are automatically enrolled in our Cradle Roll. The child being baptized is given a Children's Picture Bible and the family has their picture posted on the board in the church hallway and has members pray for them. If questions, call Sherry Sebert 871-3084.

Books & CD Library: Christian books, videos and CD's are provided for our members to use. It is located in the corridor leading to the narthex and church. The weekly church services are recorded on CD's for those unable to attend services. Contact the church office if interested in obtaining a CD.

Parish Hall, Projects Room or Pavilion Rental: call the church office. There will be a fee charged, depending on the use. The Projects Room is not available during the school year.

Off to college? Military Service? The congregation seeks to keep in touch with young people away at college or in military service. Please notify the church office of the address away from home and help us to keep it current.

St. Paul Trust Investment Fund: is an opportunity to build the principal in an account and to enable the interest to fund church related projects. Investments are received anytime. Applications for funds must be made through a St. Paul board and can be found in the church office. Your gift to our fund is the gift that keeps on giving. When a member designates St. Paul Lutheran Church as a beneficiary of their estate, they can specify exactly where they would like their gift to go. Some examples might be (General Fund, Building Fund, Missions, School, or Trust & Investment.) If the gift is not specified, the gift will go to the Trust & Investment Fund per the bylaws in the church constitution.

Board of Elders

We began the year welcoming Jim Weber, Steve Kern, and Richard Harpst to the Board of Elders. Thanks were given to Tim Brown, Kenny McKee, and Tim Sergent for their dedicated service on the Board of Elders.

The biggest problem faced by the Elders and the congregation was the COVID lockdown. Our congregation was immediately affected by the cancellation of in-person worship services. Fortunately, we were able to provide worship online through streaming. There were both pros and cons to this situation. While we were still able to provide worship and were able to reach people across the nation with our streamed services, we, as a congregation, felt the strain of "giving up meeting together, as some are in the habit of doing, but encouraging one another—and all the more as you see the Day approaching" Hebrews 10:25. We have truly missed our family, fellowship, and kneeling at His altar to receive Him who comes to us in His body and blood. Many of the plans the Elders planned have been put on hold until this pandemic is resolved.

Glenn Brown and Steve Kern attended a facility security meeting at St. Francis in Otisville and were in the process of arranging a local police officer to evaluate our facility to offer better security. That plan is on hold. Through the efforts of Glenn Brown, the Elders approved a summer Gospel concert series to reach out to our community. That was cancelled. It was also the plan to reinstate Small Group In-Home Bible Studies. That also has been put on hold until safer conditions occur.

In May, the Elders held a Special Meeting to discuss re-opening the church for worship. In order to follow State of Michigan guidelines, we could do this with no more than 100 in attendance, 6 feet between family groups, and the wearing of masks. The Elders also put in place an entrance and exit routine to minimize contact. All of this was done in keeping with the 5th Commandment in mind, to do no harm to our neighbor. Saturday Service would be held at 7:00 p.m. and Sunday Service would be held at 10:00 a.m. This was decided to keep attendance numbers at 100 or less in each service and to avoid having to disinfect the sanctuary between services. Continued adjustments will be made as the rules change.

Elders also made calls to members during the lockdown to see how they were doing and if there was anything the church could do for them during this stressful time. Members were told of the streaming worship services and the availability of a service DVD if they did not have internet.

Pastor's reported to Elders that the weekly Gathering on Thursday nights has been well attended. It is a time of fellowship, worship, Bible study and prayer. However, there is concern about the attendance on Sunday Bible Study. Pastors are spending time in preparation and having from 0-3 people taking advantage of the study. A survey was conducted in an attempt to move service times and Bible study times around, but it was not met with much enthusiasm.

Elders approved a video Children's Christmas program which will be spread out from Advent through Epiphany. Pastors are seeking ways to purchase DVD players for our members who do not have the internet or a DVD player so they can participate in worship. Elders approved a proposal for Salary and Personnel to consider which would increase the pay of the organists.

The Board looks forward to a return to normalcy and opportunities for us all to be together again as a church family.

April - We were able to give \$200 toward a member's medical bills.

May, June, July, August - No meeting due to Pandemic.

September - Money given to Lola Wendt to help provide meals for shut-ins and people struggling.

October - City Rescue Mission of Saginaw lunches resumed.

November - The Giving Tree was started. We needed to adjust the way things are done due to a change at Wellspring. We will only be able to send gift cards or money will be direct deposited to them. Luanne Jaruzel finished her last term. Monica Koeltzow was elected and Melissa Wagner was re-elected.

December - The Giving Tree helped five local families this year. We also assisted the public school with eight of their families. The board sent a compassion gift to a family member who lost a loved one.

Stephen Ministry

Stephen Ministry has become an integral way in which St. Paul reaches out to its members and community by providing caregiving ministry. Since 1985, your Stephen Ministers—all members who have received 50 hours of care-giving training—have provided one-on-one, Christ-centered Christian care to individuals experiencing crises such as loss of a loved one, divorce, a terminal illness, loneliness, unemployment, hospitalization, or spiritual struggles. Presently, we have 10 people who are actively matched in providing this care.

Over the years, we have trained and commissioned many Stephen Ministers, and although the majority of them are currently not officially matched, we do know that they are actively using their training in their everyday lives as they comfort the sick, bring joy to shut-ins, and serve their families with love.

This past year has been especially difficult for us to meet with our care-receivers on a one-to-one basis, as well as meeting together in our Supervision group. That being said, our people are deeply committed to this ministry and have figured out creative ways to "be there" for their matches. Strategic Planning Report

September 2019: About 17 months ago we initiated our planning process by meeting with the teachers and prioritizing needs. Since that meeting, we met several times beginning in the fall of 2019 and gathered input from various planning leaders and created a list of Ministry and Structural needs

September-February 2020: We held several meetings during this time and identified some items (**social media**) that could be implemented immediately. Several members had the skills and desire to expand our online presence and live streams. Along with this came the need for quality equipment, presentations to the congregation and a Trust & Investment request for equipment. At the same time, the pandemic was starting to impact our in-person worship and the option of watching online became our only option.

June 2020 and going forward: I was asked to help with the current planning needs. We created a list of "now" priorities and shared this with planning team members and church leadership. They included:

School Marketing: Online videos, signs, social media presence, classroom videos, etc.

Current Staffing & Financial Discussions: Filling positions, cost of living, and retirements.

Debt: Encourage paying off early.

Social Media Presence and Innovative Out- reach: Support our current efforts to reach and engage people (i.e., The Gathering, 202ONE, Mission Possible, Sunday morning Bible studies, Online devotions like Odd man out, Facebook policy, live streaming, videos, etc.

Engaging our members not attending in person: Personal contacts by our Elders and others.

St. Paul Lutheran Church and School responded under particularly challenging circumstances.

- General giving was up by \$40,000 in 2020.
- K-8 school numbers actually went up; however, Preschool numbers were significantly lower.
- Our Social Ministry outreach sent out over 300 val entines to shut ins.
- Our online ministry has exceeded everyone's expectations. In 2020, sixty-one services were live streamed. Four teams were established to continue the Sunday streaming and special services.
- The principal on our debt was reduced with contin ued giving and some additional generous gifts. The mortgage could be paid off by winter of 2022 or sooner.
- In person attendance is increasing. We are also talking about how to return to activities that oc curred prior to the pandemic. Zumba is back; Fish Fries are back, and other activities are being planned.

Planning issues on the "Now List" that still need some immediate attention are:

er. Teachers are in demand, and our base pay for our called faculty is not attracting replacements. We have an open position, and some retirements will be occurring in the near future. About 90% of our general giving is going for salary and benefits, and we have a deficit budget. We need to continue talking about these issues and present options to the voters. It is recommended that a group of people pursue this topic and come up with options and costs.

Marketing our school. Preschool was significantly lower, because many parents were keeping their children home. We need to celebrate and promote our National Lutheran Schools Accreditation. We also talked about funding and expanding our Grantparent program to provide more financial assistance. This emphasis is especially important in the spring.

Long Term Vision

- Structural: The Trustees are working diligently on this and will have more detailed information to present to the voters. They are listed in priority.
- New roof
- Parking lot
- Boiler components
- Ministerial and Program visions (Snapshot of information gathered in random order)
- Grantparent Program: Expand & Promote to the Congregation (Stimulus for school enrollments)
- Focus Within: Evaluate and increase the financial support of our faculty and staff.
- 125th anniversary Celebration: Planning Committee for Summer of 2022.
- Family Life Ministry position: New position
- Specialized Ministry Pastor (SMP) Position: New position (member from our congregation is in terested in this.)
- Infant Day Care: Top priority of the school staff & identified as a local need
- Outdoor Summer Concerts for all ages
- Bring back or create annual events held at our facility (i.e., Fall Festival)
- Gospel Series: July/August 2021
- Local Missions: Identify and encourage our membership to reach out in our community
- Trust & Investment: Promote and conduct educational sessions about estate planning and wills.
- Building Expansion: Expand Narthex, build additional rooms, and develop a covered approach for dropping off/picking up members. This is a major building addition and would need a detailed analysis for further discussion.

I hope this provides some clarification as to the "Now Planning" and future vision of St. Paul Lutheran Church and School. Considering the challenges God has given us, He has blessed us in many ways. If anyone has any further questions, feel free to call or text me at 906-235-4968.

There were three distinct divisions to the occurrences in 2020: January to March 13th may be described as "normal". Our year started as had years prior. Coming back from Christmas vacation our school family returned to the familiar setting of the classroom. In January, the second quarter ended, teachers attended a conference at Valley Lutheran and our mission emphasis was the Rescue Mission of Saginaw. NWEA testing, Moms and Muffins, and Jump Rope for Heart were some of the highlights of February. Our mission emphasis was Hearts for Jesus. During the first portion of March, students and staff celebrated Lutheran Schools Week with a variety of activities and service opportunities. Kindergarten Round-up and Pre-school Open House were conducted on March 15th.

March 16th – May 22nd proved to be anything but normal. St. Paul Lutheran School was placed in lockdown due to a worldwide pandemic caused by the Covid 19 virus. Online instruction was provided to our students. This was a major challenge, since most of our teachers had little experience with this method of instruction. However, they all stepped up to the challenge and with God's guidance we were able to continue to provide a Christian education using our curriculum. Students and teachers communicated online. Instruction and assignments were presented and submitted using Google Classroom, Zoom, etc. Learning in a classroom, playing at recess, conducting Chapel with Chapel buddies, field trips, assemblies and much more were placed on hold as we remained safe and prayed for an end to this disease. With modifications, we were still able to conduct Eighth Grade, Kindergarten and Preschool graduations.

Summer months were spent developing policies, composing our Michigan Return to School Roadmap and Return to School Toolkit and planning for face-to-face or online instruction.

August – December can best be described as a hybrid situation. St. Paul was blessed to be able to conduct face-to-face instruction. Following state requirements, students needed to wear a face covering, handwashing was a frequent occurrence, and social distancing was required. We were still able to worship our Great God in Chapel, but were unable to have Chapel buddies. Assemblies, field trips and most sporting events were not allowed. Due to some of our staff contracting the Covid virus, St Paul was closed from November 4-11. A tremendous blessing was to still be able to provide a modified Children's Christmas Service. Since we were unable to meet together as a large group, each class developed a vignette on one of the characters from the Christmas story centered on the school's 2020 theme, *Sent to Serve*.

Through all the change, difficulties and uncertainties, "God has been our refuge and strength." We pray for His continued blessings and protection as we enter 2021.



June
